In 2022, we celebrated 20 years of *Gale Primary Sources*. The program that began with the releases of *Eighteenth Century Collections Online* and *The Times Digital Archive* has developed into a global resource that encompasses more than 250 million images of material across cultures and centuries.

Back in 2002, the intention was to broaden the capabilities that digitisation could bring, especially through full-text searching. The resources, both in concept and user design, were aimed firmly at faculty. Much has changed in the intervening years, and now student researchers and classroom usage are key considerations during the development of new titles for the *Gale Primary Sources* program.

For student researchers who find vast amounts of material daunting, we've recently added Learning Centers to many of our archives. These Learning Centers guide students in search of a path through a vast array of materials that comprise the *Gale Primary Sources* universe. Our Learning Centers include case studies, ideas for writing topics, and recommended search terms—all designed to orient the user and provoke discussion about possible avenues of research.

You understand the challenges and rewards of creating a diverse learning environment. At Gale, our mission is to help your academic institution **expand the possibilities of research**. Through feedback from librarians, faculty, and students, we recognise the vital role that *Gale Primary Sources* can serve in supporting today's critical conversations, and we'll continue to expand our offerings to support them.

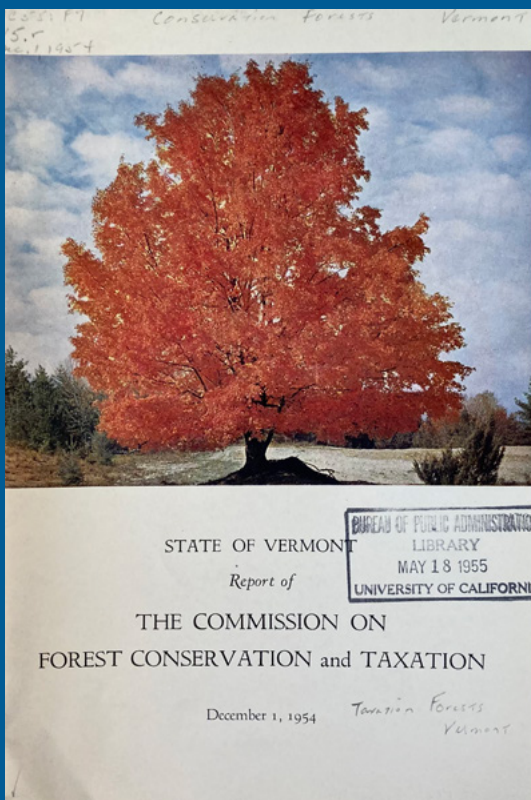
New archives such as *Decolonization: The Politics and Independence in Former Colonial and Commonwealth Territories* bring the voices of colonized people to the forefront, telling the story of worldwide liberation struggles from the perspective of those who campaigned for their own independence. These new archives will soon be joined by offerings that focus on relevant topics such as the refugee crises during the early Cold War era; the history of environmental policy and movements; the social, cultural, and political history of the Latinx and disabled communities in North America; and other areas of research. 

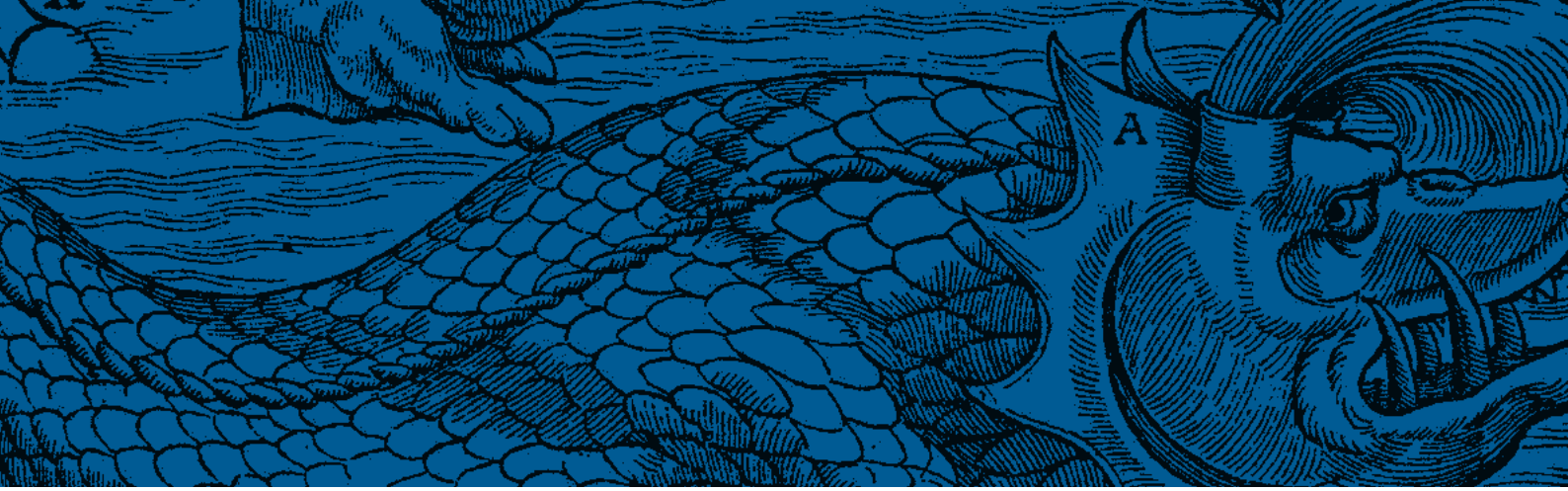

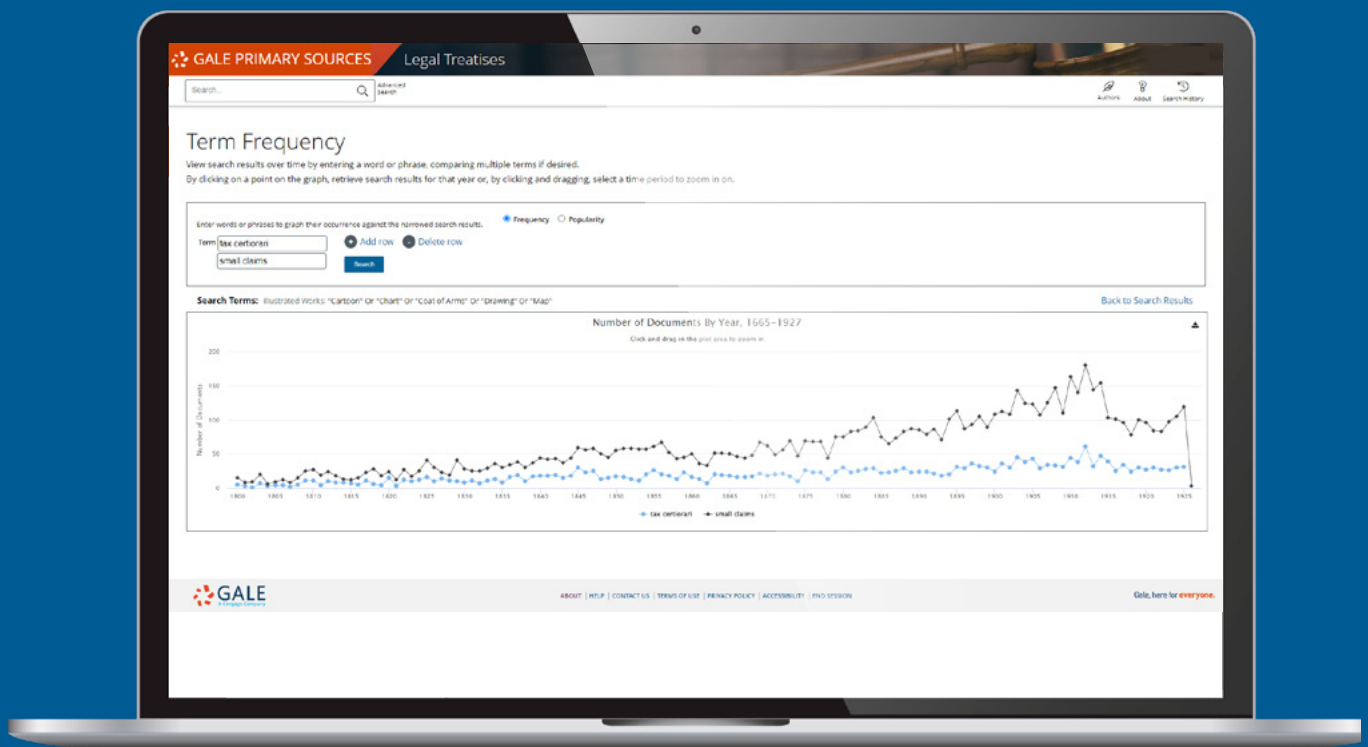

The latest collection in this award-winning program examines the narratives and effects of Far Left political theories, including Marxism-Leninism, Maoism, Trotskyism, anarchism, and more. The collection, covering primarily the first half of the twentieth century and containing accounts that span the globe, offers rare, firsthand accounts of those who witnessed and participated in communist, socialist, and far-left groups, and chronicles their impact on capitalist nations.

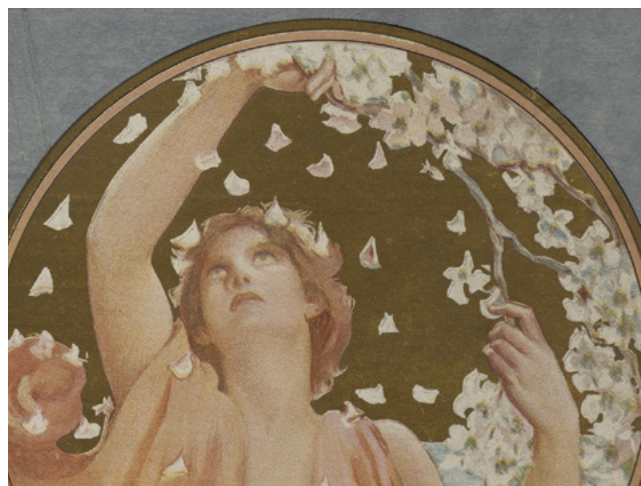

American Historical Periodicals from the American Antiquarian Society, Part VII

The seventh collection of newly digitised holdings from the American Antiquarian Society features periodicals covering a wide variety of topics, including archaeology, art, commerce, education, health and medicine, literature, regional and national history, manufacturing, military history, politics, religion, and youth culture. This diversity of periodicals gives researchers multiple lenses through which to view the American experience.

Decolonization: Politics and Independence in Former Colonial and Commonwealth Territories

Crucial to research related to processes and movements of decolonisation are the voices of local players who helped forge their country's new direction. This archive presents political ephemera and organisational material produced during the twentieth century in over 70 previously colonised countries and territories. This collection sheds light on national political developments and social movements that followed decolonisation, and how former colonies and Commonwealth territories negotiated their own agency and futures.

State Papers Online Colonial: Asia, Part I: Far East, Hong Kong, and Wei-Hai-Wei

This collection is the first installment in *State Papers Online Colonial*, which brings British Colonial Office files from The National Archives in the United Kingdom to a global audience. These Colonial Office working files illustrate two very different sides in the colonial relationship: a British government whose main priority was the acquisition of commodities, wealth, and labour; and the local people living under colonial rule and British-style institutions for law, health, education, policing, defense, agriculture, and industry. The over 4,000 issues contain more than just articles on education in the UK. *TES* serves as a repository of opinions, reviews, and reports on matters extending beyond pedagogy, encompassing educational reform, social policy, the effects of Anglo-American education on local cultures in other countries, and much more.

As the 13th installment in *The Making of Modern Law*, this collection is devoted to briefs and records of selected cases filed with the U.S. Courts of Appeals, the court system that hears cases prior to their review by the U.S. Supreme Court. Covering over 500 different cases, this collection puts a concentrated focus on key issues that continue to occupy the American social and political landscape, such as reproductive rights, gun ownership laws, incarceration and the rights of prisoners, environmental policy, and more, filling critical gaps in prior offerings on a case-by-case basis. This key resource is a recommended addition to libraries already subscribing to *The Making of Modern Law*.

We couldn't be more pleased that *Archives of Sexuality and Gender* is a Platinum Award winner at the 2023 Modern Language Awards. This sixth collection not only highlights the role of community groups and organisations in modern LGBTQ history, it also sheds light on other areas of gender and sexuality, such as alternative sexualities, gender equality, sex and religion, disabilities, and race and ethnicity. The materials provide coverage of activism and social justice issues, highlight disabilities in queer society, and document diverse ethnic communities across North America. These collections detail how identities developed under different social conditions and within different regions of North America, and how communities grew around dedicated, often courageous, individuals.

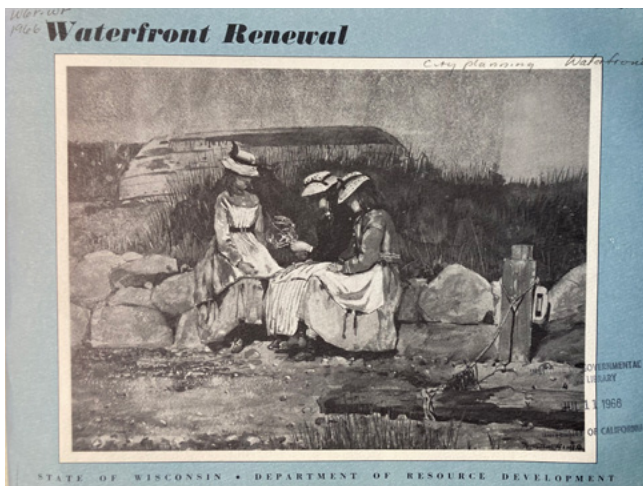
Mail on Sunday Historical Archive, 1982–2011

Established in 1982 under the same ownership as the *Daily Mail*, *Mail on Sunday* has been one of the top Sunday newspapers in the United Kingdom for four decades. Generally conservative in its stance, *Mail on Sunday* has covered British politics on the domestic and international stage through its frequently contentious embrace of tabloid journalism. Researchers can explore every full issue to follow both major news stories and perspectives on social trends and debates of the era.

Environmental History: Conservation and Public Policy in America, 1870–1980

This diverse collection offers a glimpse into the many actors and agencies whose efforts shaped modern policy and legislation in the areas of conservation and environmental protection in the United States. Researchers will find the work of individual movers and shakers, such as early environmentalists George Bird Grinnell and “father of forestry” Joseph Trimble Rothrock, as well as later activists like Rosalie Edge and Velma “Wild Horse Annie” Johnston. They can sift through the records of agencies such as the U.S. Forest Service and the U.S. Bureau of Reclamation, as well as the many departments focused on conservation and land-use matters, from water conservation to wildlife management, at both the state and municipal levels.

Disabilities in Society, Seventeenth to Twentieth Century

Disabilities in Society, Seventeenth to Twentieth Century demonstrates how society has interacted with and treated individuals with disabilities historically. Materials include personal memoirs, records of treatments, methods of education, and forms of remediation. Reports and proceedings of organisations and institutions that sought to help or heal those with disabilities are included, as well as records of policies and programs. Through this collection, researchers will grasp the many forms of institutional discrimination, political exclusion, and social control under which disabled individuals struggled. This collection also documents the rise of disabilities movements and their efforts to gain political power. Materials chronicle how individuals were classified and treated, and how some overcame physical or mental challenges to change perceptions of what it means to be disabled. China and the Modern World: Hong Kong, Britain and China, Part II, 1965–1993

Digitised primarily from records of British Foreign and Commonwealth Office (FCO 40), this collection presents a twentieth-century thematic collection that documents Hong Kong's transformation into an international metropolis and financial centre during the Cold War period. Key topics covered include the labour disturbances and riots of 1966–1967, social reforms of the 1970s, response to the Vietnam War and influx of Vietnamese refugees, espionage and intelligence operations, police corruption, reactions to Chinese political and economic events, anxieties about the city's future, and negotiations and preparations for the city's handover to China.

Refugees, Relief, and Resettlement, Part II: The Early Cold War and Decolonization

This second installment in the *Refugees, Relief, and Resettlement* series combines primary sources from several source libraries to tell the story of the effects of the early Cold War and decolonisation and independence movements on local populations. The collections offer many examples of how the consolidation of the post-World War II Soviet empire, the forced repatriation of European colonists, and the displacement of local populations from deadly post-independence struggles played out across Europe, Africa, and Asia.

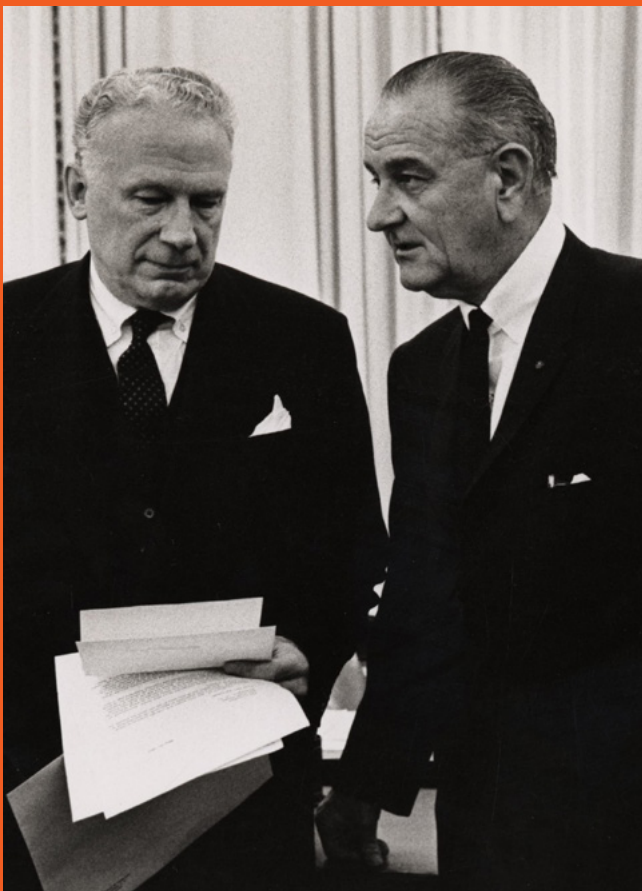
