State Papers Online Colonial: Asia, Part I: Far East, Hong Kong, and Wei-Hai-Wei contains British Colonial Office working files that illustrate two distinct sides in the colonial relationship: a British government whose main priority was the acquisition of commodities, wealth, and labor; and the local people living under colonial rule and British-style institutions for law, health, education, policing, defense, agriculture, and industry. Documents include original correspondence, entry books of incoming and outgoing letters, confidential print, maps, and photographs.

VALUE OF THE COLLECTION:

- **Supports Researchers:** Contains mainly English-language documents on a major sector of Southeast Asia.

The inaugural collection in this new archive offers researchers and students multiple subjects and angles for new research topics in Asian and colonial studies. Whether users benefit from the country limiters and searchable printed, typed, or handwritten documents, or they browse through individual files and volumes, some of these documents will be read for the first time since release into the public domain, and all will be viewed with fresh eyes and new perspectives.

The earliest documents are comprised of the British government's correspondence with the East India Company about trade in Asia, rivalry with the Dutch, the Opium trade, and the first British embassy to China of 1793 to 1794. Later documents, many formerly confidential, cover the development of trade and administration of the Far East territories. Subjects include control of opium trafficking, rubber production, Kuomintang activities, military administration after World War II, reconstruction in the Far Eastern colonies (Borneo, Hong Kong, and Malaya), constitutional reform of Hong Kong, and the effect of the closure of British firms in China.
