

State Papers Online: Eighteenth Century, 1714–1782: Part IV – Scandinavia, Eastern Europe, and Turkey covers British relations with Russia, Sweden, Denmark, Prussia, Poland and Saxony, the Barbary States and the Ottoman Empire, and includes papers from the reigns of three 'Great' rulers, Peter I and Catherine II of Russia, and Frederick II of Prussia. Alongside these are series of correspondence of the Secretaries of State with foreign ministers in England, Entry Books, Ciphers and Confidential records.

The northern behemoths of Russia and Sweden began the eighteenth century with a war that altered the power balance of northern Europe. The Swedish Empire declined and the country entered an 'Age of Liberty', whilst Tsarist Russia emerged as an imperial power. Prussia, a heavy-weight in European politics, was alternately ally and enemy to Great Britain; the shifting alliances of this martial period are made particularly clear in the 'Treaty' series included in this collection. For Poland, the century was spent defending its territories from stronger powers, leading up to the First Partition of Poland in 1772.

British communications with Denmark, and with the Barbary States and the Ottoman Empire are also here, the latter a relationship that took British diplomats beyond the standard European Protestant-Catholic dichotomy.

- Basic and advanced search
- Time-saving limiters, allowing users to limit results by date, reign, collection segment, or manuscript volume, language, illustrations and maps
- Browse manuscripts, enabling users to view a single volume of manuscripts, or jump from volume to volume – crucial for finding documents which are not fully calendared
- Calendar entries linked to each facsimile manuscript document
- Manuscript document in full-screen view with zoom from 5%-400%
- The ability to view two manuscripts side by side for comparative analysis
